Trustees Meet with Hanger in San Antonio

The Foundation Trustees and the IWUSA Governing Body held their fall meetings in San Antonio, Texas, October 18 – 19, 2013.

Friday, October 18th everyone met with Steve Mandacina and Autumn Babineau from Hanger Clinic.

Some important facts about Foundation giving to Hanger are listed to right, other facts are below.

- \$34K in Limb Bank.
- 56 children have been fitted since 2004.

- Average cost per child is \$9000.
- Average age of children at time of fitting is 9.5 years.

The Medicare value is product and services. The Foundation only pays for the product, at a discounted cost. Hanger clinicians donate or find other ways to pay for their time, occupational therapy and other services that may be associated with a child receiving a hand.

The Limb Bank is where Hanger keeps limb parts that can be refurbished and used for another child. IW funds only cover actual components that can be returned once the child has grown out of them. We all know how fast children grow and most insurance companies do not pay for refitting of a limb as often as it should be done. Thus we have the Inner Wheel Limb Bank.

Interesting Facts:

- Since 2004 IW Foundation has given \$442,152.
- \$442,152 has a Medicare value of \$1,326,457.
- Presently 10 children are "in the cue".
- \$44,591 IW funds remaining for this year (June 30, 2014).
